## LUDS July 2022 Trial Instructions and Guidelines

- LUDS (Level Up Dog Sports) have put in place the following procedures for our agility trial at LUDS for the safety of our exhibitors and adherence to State and CDC requirements and guidelines.
- 
- If you do not feel you can comply with any of these requirements, please do not enter our trial, we will look forward to seeing you at a future trial.
- 
- If you are fully vaccinated against Covid-19 you do not need to wear a mask inside the building, or at the trial site, but it is highly recommended. If you are NOT vaccinated against Covid-19, a mask, covering mouth and nose, must be worn at all times, inside the building even when running your dog. You may remove your mask outdoors.
- 
- Please practice social distancing when you are inside the building. Although Level Up is currently not requiring mask wearing for those who are fully vaccinated, it is recommended that you wear a mask while inside the building.
- 
- These rules and guidelines may be subject to change and we will keep you updated with any changes that occur prior to closing should you wish to withdraw your entry.
- 
- There will be no paper course map copies. Maps will be posted to the Sunrise Agility's website and through the Agility Gate app.
- 
- **PLEASE NOTE: The Agility Gate app is an aid only – it is still the responsibility of the handler to make sure they are at their walkthroughs and are at the gate when it is their turn to run – GKC is not responsible for any delays in communications due to delays with wireless networks.**
- 
- See **Site Information** for information on crating in the building. If you plan on running your vehicle, please park so your exhaust does not go into another vehicle or towards the building.
- 
- One way entry/exit as follows: Enter the building on the parking lot side and exit on the other side where the street goes between the buildings. We will be lining up the next five dog & handler teams to run. Please respect each team's space in the queue. Exhibitors are responsible for arriving on time for their walk-thrus and runs. LUDS will sanitize equipment and LUDS will disinfect all surfaces, including the floor and equipment, before the event and after each day of the event using EPA-registered disinfectants.
- 
- Per AKC guidelines: "exhibitors may choose to place leashes in their pockets or wear them (around waist, cross body, etc.) during their runs. If the dog grabs the leash, this will be scored as "E". If the leash falls out of the handler's pocket, or off of their body, there is no call unless the dog were to grab it." A leash-runner will be available for exhibitors who do not wish to carry their leash while on course.

**FEO RUNS (For exhibition only) ARE OFFERED AT THIS TRIAL.  
(T2B ONLY)**

Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

**DOG ELIGIBLE TO ENTER**

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds

Express mail entries must include the signature waiver allowing them to be left at the secretary's address (max 10 entries per envelope). No entry shall be made, and no entry shall be accepted that specifies any conditions as to its acceptance. **No entries will be accepted by phone, fax or email.**

**Payment must accompany entry, no direct payment to LU account (such as Paypal) allowed.** No hand deliveries will be accepted in the first twenty-four hours following the opening date and time. Entries must be submitted on Official AKC-form with correct entry-fees listed. One dog per form. **Please read the section: "Class changes effective January 1, 2020," posted in the premium, for instructions when entering same dog in multiple heights or mixed regular and preferred classes.**

Agreement on back of form **MUST** be signed. Photo-copies must be legible with original signature. Max 10 entries (dogs) per envelope (includes Express-mail-entries). **NO emailed forms, fax or telephone entries accepted.**

Illegible entries will not be processed and will be returned to the exhibitor. **Returned checks do not constitute a valid entry and the Trial Secretary will add a \$30.00 collection fee to the amount of each returned check.** Be sure to include correct fees. Overpayments less than \$10 will not be refunded

This trial is accepting online entries through [LabTestedOnline.com](https://www.labtestedonline.com). During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows. 30% online per day, 70% each day. If either form of entry has not filled at the end of the 48-hour time period, the club reserves the right to decrease or increase either one accordingly.

**MEASURING AND HEIGHT CARD INFORMATION**

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the Judge of Record PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 24C height division. However, if a Volunteer Measuring Official (VMO) or an Agility Field Rep is present; ALL dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog before its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

**PLEASE NOTE:**

Effective 1/2/18, the 26-inch jump height division is replaced by the 24-Choice jump height division.

RINGSIDE - Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

**CLASS CHANGES EFFECTIVE JANUARY 1, 2020**

**Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day**

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

**When calculating entry fees, treat multiple entry forms for the same dog as if only one form had been filled out. In other words, the 1<sup>st</sup> run entry fee is only paid once per day, per dog, even if that dog's runs have been submitted on multiple entry forms.**

**FIX AND GO ON (FNG)**

**Fix and Go On**

Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

## OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. Rubberized contacts will be used. All classes will take place on synthetic turf. Ring size will be a minimum of 78 x 114 square feet. Clip n Go Rubberized Contacts will be used.

### Course WALK-THROUGHS AND Warm-Up INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent. No umbrellas allowed on course during walk-throughs.

A warm-up area, consisting of a regulation agility jump, will be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

## RIBBONS AND AWARDS

- ❖ Flat ribbons will be awarded to the first through fourth place dog in each jump-height division in each class.
- ❖ Qualifying ribbons will be awarded to all dogs receiving a qualifying score
- ❖ Agility Grand Champion (AGCH) ribbons will be given to those earning this award at this trial
- ❖ MACH/PACH Rosettes and a MACH/PACH bar will be given to exhibitors earning a MACH/PACH title at this trial.
- ❖ New Title ribbons will be given to dogs earning a new title.
- ❖ Double "Q" ribbons will be given to those exhibitors who double Q in the STD and JWW Master classes on the same day.

All ribbons must be claimed by the end of the Trial; none will be mailed.

## NOTICE TO EXHIBITORS

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. It is expressly understood that the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any entry fees will be made. All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. No dogs may be left tied to trees, cars, fences, etc.

Dogs under 4 months of age are not allowed at this trial. Entry fees will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reason of civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. Exhibitors are responsible for being at the ring gate when it is their turn to run. No classes will be held up by a late exhibitor.

**This club does not agree to arbitrate claims as set forth on the Official AKC Entry Form for this event.**

## MOVE UP REQUESTS

**Move ups must be sent in writing** (e-mail is acceptable and preferred-**NO** Texts or Instant Messages) to the Trial Secretary for the July 8, 2022 trial, **no later than Monday, July 4, 2022, by 6:00 PM**. Move ups from Saturday to Sunday must be submitted in person to the trial secretary no later than 15 minutes after the last class on Saturday, The trial secretary will be more than grateful if you will do your move-ups as soon as possible.

## BIS REFUND INFORMATION

### **Bitches in season**

will not be admitted to the trial. Any exhibitor with a bitch entered, which is in season on the trial date, will be refunded the entry fee, less \$3 per run (each day), upon written certification from a veterinarian.

## SITE INFORMATION

### No Exhibitor Setup prior to Friday.

**Inside crating** is restricted to workers who have signed up to volunteer. If space is available non – workers may also crate inside but priority will be given to workers. The inner crating room is restricted to club officials only.

**Shoes** - handlers need shoes with low traction to avoid "sticking" to the turf. Trail shoes do not work well. Please choose something with less tread.

**Masks** are required in the building and during walkthroughs, unless fully vaccinated against COVID-19. Masks are not required while running. If applicable, please put your mask back on before exiting the ring.

All **turf accidents** must be reported immediately and a \$5 clean up fee has to be paid to Level Up Dog Sports. Dogs must be kept on leash when not in the ring.

## **FEO (FOR EXHIBITION ONLY) AND FIX AND GO ON**

As of January 1, 2022

For Exhibition only (FEO) and Fix and Go On are permanent parts of the AKC Agility program.

### **Entering for Exhibition Only (FEO)**

FEO allows exhibitors to work with their dogs in a trial environment. FEO is only offered in the Time 2 Beat and FAST classes. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).

- Toys are allowed in the ring. Toys must be non-audible and may not leave the handlers hand. Toys that roll freely may not be used.
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score. Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
