This is the expected running order, adjustments may need to be made depending on number of entered runs, or other considerations.

Judging will start no earlier than 8 a.m. each day—Your Final Confirmation and Trial Information, emailed after the close of the trial, will provide details on start times each day. Heights will be low to high Friday, high to low Saturday and low to high Sunday.

NOTE to avoid ring conflicts for Master Standard and JWW so that the same height is not running simultaneously in both rings, we will most likely shift the height running order for those classes in one of the rings. (Probably the JWW ring.)

Open and Novice FAST MAY walk together; and will run consecutively
FEO is offered at this trial (T2B and FAST only)

Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

DOG ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word “dog” is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog’s physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds

This trial is accepting online entries through LabTestedOnline.com. During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows. 30% online per day, 70% each day. If either form of entry has not filled at the end of the 48-hour time period, the club reserves the right to decrease or increase either one accordingly.

DIRECTIONS TO THE TRIAL SITE

Coming from North or South on GA 400:

Exit GA 400 at Exit 10 (Old Milton Pkwy / GA120). Turn West on Old Milton Pkwy (Left turn if coming from the South, Right turn if coming from North). Continue past GA Hwy 9 (Main St) to Wills Road. Turn Left on Wills Road and Equestrian Center is on Right.

Coming from West:

From Hwy 92, turn Left onto Hardscramble Rd (at Target shopping center). Continue until it ends at Crabapple Road and turn Left. Immediately turn Right onto Rucker Rd and continue to Wills Rd. The Equestrian Center is on the Left.

Coming From East:

From Pleasant Hill Rd/States Bridge Road/Old Milton Pkwy – Cross over GA Hwy 9 (Main St) turn Left on Wills Rd. Equestrian Center is on the Left. From Holcomb Bridge Rd – Proceed to GA 400 and follow North/South Directions above.

OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. Two rings, 100x100. Outdoors, under cover, on packed dirt. 24" spaced weave poles; Rubber contacts, plastic jumps, displaceable tire, and electronic timers,

WALK-THROUGHS AND Warm-Up INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only and will be limited to a maximum of 25 handlers. Handlers with multiple dogs/conflicts: Tell the gate-steward if you need to move your dog, they will help you manage your conflict.

A warm-up area, consisting of a regulation agility jump, will be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

RINGSIDE - Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

ENTERING FOR EXHIBITION ONLY (FEO)

- For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes Participation in FEO is non-qualifying.
- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).

FIX AND GO ON

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

ENTERING A MIXTURE OF REGULAR AND PREFERRED CLASSES WITHIN THE SAME TRIAL WEEKEND – MULTIPLE JUMP HEIGHTS WITHIN THE SAME TRIAL DAY

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

PLEASE NOTE:

Effective 1/2/18, the 26-inch jump height division is replaced by the 24-Choice jump height division.

MEASURING AND HEIGHT CARD INFORMATION

Jump height cards are not required to be submitted with the entry form.

The "height at withers" box on the entry form MUST be filled in with dog's height at withers. You must declare an estimated height at withers if your dog needs to be measured.

AKC RULES AND REGULATIONS

All exhibitors should obtain a copy of the Regulations for Agility Trials by downloading them from the American Kennel Club website at <http://www.akc.org/rules/>.

MOVE UP REQUESTS

Move ups must be sent in writing (e-mail is acceptable and preferred) to the Trial Secretary for **the Friday March 10, 2023 trial, no later than Monday, March 6, by 6:00 PM.** Move ups from Friday to Saturday, Saturday to Sunday must be submitted in person to the trial secretary no later than 15 minutes after the last class on Friday & Saturday.

REFUND INFORMATION

Bitches in season will not be admitted to the trial. Any exhibitor with a bitch entered, which is in season on the trial date, will be refunded the entry fee, less \$5 per run (each day), **upon written certification from a veterinarian. Notification must be in the hands of the trial secretary** no later than 30 minutes before the start time on the first day of the trials. (Friday, March 10)

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

NOTICE TO EXHIBITORS

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. It is expressly understood that the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any entry fees will be made. All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. No dogs may be left tied to trees, cars, fences, etc.

Dogs under 4 months of age are not allowed at this trial. Entry fees will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reason of civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. Exhibitors are responsible for being at the ring gate when it is their turn to run. No classes will be held up by a late exhibitor.

Canine Capers Dog Agility Club, the trial secretary, their agents, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians.

Owners or handlers entering dogs in a trial do so at their own risk and agree to assume responsibility for any damage caused by them, or by their dogs. They also agree to abide by the Rules of The American Kennel Club and the current edition of the AKC Agility Regulations.

The safety of the dogs is of primary importance. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all of the obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior, may, at the discretion of the Trial Committee, be asked to leave the show site. There will be no refund of entry fees if a person is asked to leave the trial site.

PRIZES AND AWARDS

Ribbons or rosettes will be awarded to the 1st through 4th place teams in each jump height in each class. Dogs must qualify to receive placement ribbons. Qualifying ribbons will be awarded to all dogs receiving qualifying scores. Teams earning a title will receive a new title rosette. MACH and PACH rosettes and bars will be awarded to dogs that earn those titles at this trial. All ribbons must be claimed by the end of the Trial; none will be mailed.

INSTRUCTIONS

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
