Judging will start no earlier than 8 a.m. each day—Your Final Confirmation and Trial Information, emailed after the close of the trial, will provide details on start times each day. Heights will be low to high Friday, high to low Saturday and low to high Sunday.

FEO is offered at this trial

Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

**DOG ELIGIBLE TO ENTER**

---This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

---Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word “dog” is used in these regulations it includes both sexes.

---Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog’s physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds.

Express mail entries must include the signature waiver allowing them to be left at the secretary’s address (**max 10 entries per envelope**). No entry shall be made, and no entry shall be accepted that specifies any conditions as to its acceptance. **No entries will be accepted by phone, fax or email. Duplicate entries are not accepted.**

**Payment must accompany entry,** No hand deliveries will be accepted in the first twenty-four hours following the opening date and time. Inquiries may be directed to Tina Eastman at Sunriseagilitytss@gmail.com.

Entries must be submitted on Official AKC-form with correct entry-fees listed. One dog per form. **Please read the section: “Class changes effective January 1, 2020,” posted in the premium, for instructions when entering same dog in multiple heights or mixed regular and preferred classes.**

Agreement on back of form **MUST** be signed. Photo-copies must be legible with original signature. Max 10 entries (dogs) per envelope (includes Express-mail-entries).

**NO emailed forms, fax or telephone entries accepted.**

Illegible entries will not be processed and will be returned to the exhibitor. **Returned checks do not constitute a valid entry and the Trial Secretary will add a \$30.00 collection fee to the amount of each returned check.** Be sure to include correct fees. Overpayments less than \$10 will not be refunded

This trial is accepting online entries through LabTestedOnline.com. During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows. 40% (140 runs) online per day, 60% paper each day (210 runs). If either form of entry has not filled at the end of the 48-hour time period, the club reserves the right to decrease or increase either one accordingly.

### Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

**A separate entry form** must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

**When calculating entry fees**, treat multiple entry forms for the same dog as if only one form had been filled out. In other words, the 1<sup>st</sup> run entry fee is only paid once per day, per dog, even if that dog's runs have been submitted on multiple entry forms.

### DIRECTIONS TO THE TRIAL SITE

#### 3381 Hunting Country Rd., Tryon, NC 28782, From I-26

Take S.C. Exit #1 from I-26, toward Landrum, S.C.  
Go 1.5 miles, then turn right onto Bomar Road (look for the Land Mart on the corner).  
Go one short block and turn right onto Prince Road.  
Follow Prince Road for approximately 1.5 miles and turn left onto Hunting Country Road (just before the I-26 overpass).  
Follow Hunting Country Road for approximately 3/4 mile.  
The entrance to the Equestrian Center, Mane Gate Lane, will be on your left just before the I-26 underpass.  
For the main FENCE entrance for the FENCE Center, hiking trails and TROT barn, continue on Hunting Country Road under the I-26 underpass to the main FENCE gates on your right.

### ENTERING FOR EXHIBITION ONLY (FEO)

#### As of January 1, 2021,

For Exhibition Only may be offered at the option of the host club. FEO will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. Competitors must enter in T2B and/or FAST. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring
  - Toys must be non-audible
  - Toys may not leave the handler's hand
  - Toys that roll freely cannot be used
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

### FIX AND GO ON

Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run. Judges can stop a run at any time

### AKC RULES AND REGULATIONS

**PLEASE NOTE:**

Effective 1/2/18, the 26-inch jump height division is replaced by the 24-Choice jump height division.

**MEASURING AND HEIGHT CARD INFORMATION**

**Jump height cards are not required to be submitted with the entry form. The jump height box on the entry form MUST be filled in.**

**OBSTACLES AND RING CONDITIONS**

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. Outdoors with under cover arena on packed dirt. 24" spaced weave poles; Rubber contacts, plastic jumps, displaceable tire, wall jump, soft broad jump and electronic timers, (1) 130' x 100' ring.

**Setting for the AKC tire that will be used are as follows: 4" & 8": 4" Small (12"): 8" Medium (16"): 8" /12" Intermediate ( 20"): 16" Large (24"): 20"**

**WALK-THROUGHS AND Warm-Up INFORMATION**

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only and will be limited to a maximum of 25 handlers. Handlers with multiple dogs/conflicts: Tell the gate-steward if you need to move your dog, they will help you manage your conflict.

A warm-up area, consisting of a regulation agility jump, will be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

**RINGSIDE** - Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**BIS REFUND**

**Bitches in season** will not be admitted to the trial. Any exhibitor with a bitch entered, which is in season on the trial date, will be refunded the entry fee, less \$3 per run (each day), upon written certification from a veterinarian. Notification must be in the hands of the trial secretary no later than 30 minutes before the start time on the first day of the trials. (Wednesday November 6)

**Injury/Illness** – AKC does not require clubs to offer any refund for dogs that are pulled after closing for injury/illness. However, as a courtesy to our exhibitors BRAC offers a partial refund if a request for refund with required documentation is presented to trial secretary **as defined here**: "Dogs that cannot compete prior to the set of trials due to an injury/illness will be given a partial refund minus processing fees of \$10.00 per run in the form of vouchers to be used at any future BRAC trial. A written vet letter on office letterhead **must be in the hands of the trial secretary** no later than 30 minutes before the start time on the first day of the trials (Wednesday November 6) (Letters from chiropractors and massage therapists are not valid.)" **Injuries/illness to handlers are excluded from this policy.**

**NOTICE TO EXHIBITORS**

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. It is expressly understood that the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any entry fees will be made. All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. No dogs may be left tied to trees, cars, fences, etc.

Dogs under 4 months of age are not allowed at this trial. Entry fees will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reason of civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. Exhibitors are responsible for being at the ring gate when it is their turn to run. No classes will be held up by a late exhibitor.

**This club does not agree to arbitrate claims as set forth on the Official AKC Entry Form for this event.**

**Exhibitors should follow their veterinarians' recommendation to assure their dogs are free from internal and external parasites, any communicable diseases, and have appropriate vaccinations.**

### Pumpkin Palooza Cup Progression:

Nov 7th's A3 Class is considered both a "regular" A3 class that anyone may register for, and the designated class for the Cup Finals. Any qualifying team not entered in the Nov 7th A3 class will forfeit their opportunity to compete in the Finals. The cup is open to dogs running at their FCI height and dogs running at their regular AKC height.

### How to Qualify for Finals:

The top three qualifying teams per height in each Cup Qualifier class will advance to the Finals. If a team has already qualified during a previous run, the next qualifying team will advance to the Finals round. Again, you must enter Agility Level 3 on Sunday for a chance to run in the Cup Finals. Runs scored as "E" will not be considered for Finals.

Original running orders will be observed during the Finals. Finalist teams will be indicated with an "F" next to their names on the gate sheet.

### Cup Winners:

The A3 class on Sunday will serve as the trial's Cup Finals Round. The placement order within this class will determine the Cup winners.

### Awards

ISC Qualifying event

Placements 1st through 3rd in each height will receive a custom-painted water bucket

### AKC World Team Tryouts (WTT) 2025 Qualifying Event:

This event will be a WTT Qualifier Event. The combined scores from ISC Jumpers on Wednesday November 6, and ISC Standard on Thursday November 7, 2024 will be used to award the WTT Combined ISC Class Award. To be eligible for the WTT Combined ISC Class Award, the team must have a clean Std or JWW run and a run that has a maximum of 5 course faults (no time faults allowed) for those scores to be used to compute the Combined Score. **The Combined Class winner from the 12, 16, 20 and 24 inch height is invited to attend World Team Tryouts 2025.** They do not need to fulfill the requirement of the 4 Std/4 JWW scores. The team must also send in all the required information for entering the WTT with the fees and the entry form and meet all the other basic eligibility for WTT (including an approved pedigree). The handler at tryouts must be the same handler that won the combined award.

### **International Sweepstakes Class**

The International Sweepstakes Class (ISC) is a non-regular class providing a dog and handler an opportunity to demonstrate their advanced training and handling skills on various international style Standard and Jumpers With Weaves courses. The rules for this class are generally based on Fédération Cynologique Internationale (FCI) rules.

The variety in International Agility course designs is very diverse, so handlers should be prepared to meet the "Challenge of the Day" when competing in the ISC class. The total challenge level may be easier, more difficult, or simply different from what is currently allowed in the Excellent or Master classes. Course designs will vary widely thus testing different skills on different days.

### **Eligibility of Dogs.**

This class is open to dogs that are eligible to compete in AKC Agility Trials.

If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
